Read a second time; Committed; Proceedings in Committee interrupted by Private Bills, 131. Committee resumed; Bill reported, 133. Motion to refer the Bill to the Railway Committee; Negatived, 134. Motion for third Reading; Amendment moved, That the expenditure of so large a sum of money to give a second line of Railway from Stellarton to Pictou, is inexpedient, &c.; Amendment withdrawn; Main motion withdrawn; Order for third reading discharged; Bill re-committed; Amended; Considered, 137. Motion for third reading; Amendment moved, That the expenditure of so large a sum of money, &c., is inexpedient; Negatived, 138. Bill read a third time and passed, 139. By the Senate, 247. R.A., 403.
