

to sell Intoxicating Liquors, at the place specified in the license, for the purposes authorized by this Act, and for no other purposes.

6. But such license shall not be given to such agent until he executes and delivers to the Council appointing him a bond in favor of the Municipality, with two good and sufficient sureties, to be approved by the Council, in the sum of not less than one thousand dollars each, conditioned as follows :— 5

“ Know all men by these presents that A. B. [*the principal*] and C. D. and E. F. [*the sureties*] are jointly and severally held and firmly bound unto the Corporation of the Town of _____ in the penal sum of _____ dollars ; for payment whereof we bind ourselves, and each of us binds himself, our and each of our heirs, executors and administrators, firmly by these presents. Sealed with our seals and dated this _____ day of _____ A.D. 10

“ Whereas the above bounden, A. B., has been appointed agent for the said Municipality, to sell at [*here name the particular place*] Intoxicating Liquors for medical, chemical and mechanical, and wine for sacramental purposes only, from the _____ day of _____ to the _____ day of _____, unless sooner removed from such agency ; 15

“ Now the condition of this bond is such that if the said A. B. shall in all respects conform to the provisions of an Act passed in the 23rd year of the reign of Her Majesty Queen Victoria, and entitled, “ An Act for the suppression of Intemperance,” and to such rules and regulations as as now are, and from time to time shall be established, by the said Corporation, touching the sale of Intoxicating Liquors, the same not being contrary to the provisions of the said Act, then this obligation to be void, otherwise to be and remain in full force and effect.” 25

7. The Agent may purchase Intoxicating Liquors from any licensed manufacturer, or import the same from abroad.

8. The agent shall not purchase any Intoxicating Liquor in this Province, from any person except a licensed manufacturer, or another duly authorized agent for the sale of such Liquor. 30

9. The agent making application for such liquor shall exhibit his license if required.

10. No liquor shall be removed from a manufactory, nor imported into the Province, for him, unless the vessel containing the same be plainly marked upon some conspicuous part thereof, or upon a card or label attached thereto, with the name of the liquor, the name of the vendor, the place where purchased, the name of the agent, and the place where consigned ; somewhat after the following form, but varying to suit the occasion :— 40

11. The agent shall give a written or printed receipt for all purchases of such liquors, and receive and file all bills of purchase.

12. The agent shall not sell to any minor or apprentice, knowing him to be such, without the written order of his parent, guardian or master. Nor to any Indian, Soldier, or Seaman. 45

13. The agent shall not sell to any person known to be of intemperate habits, nor to any person whatever, after having received a written notice from a Councillor of the Municipality, a Minister of the Gospel, or a Justice of the Peace, that the use which such person makes of Intoxica- 50
