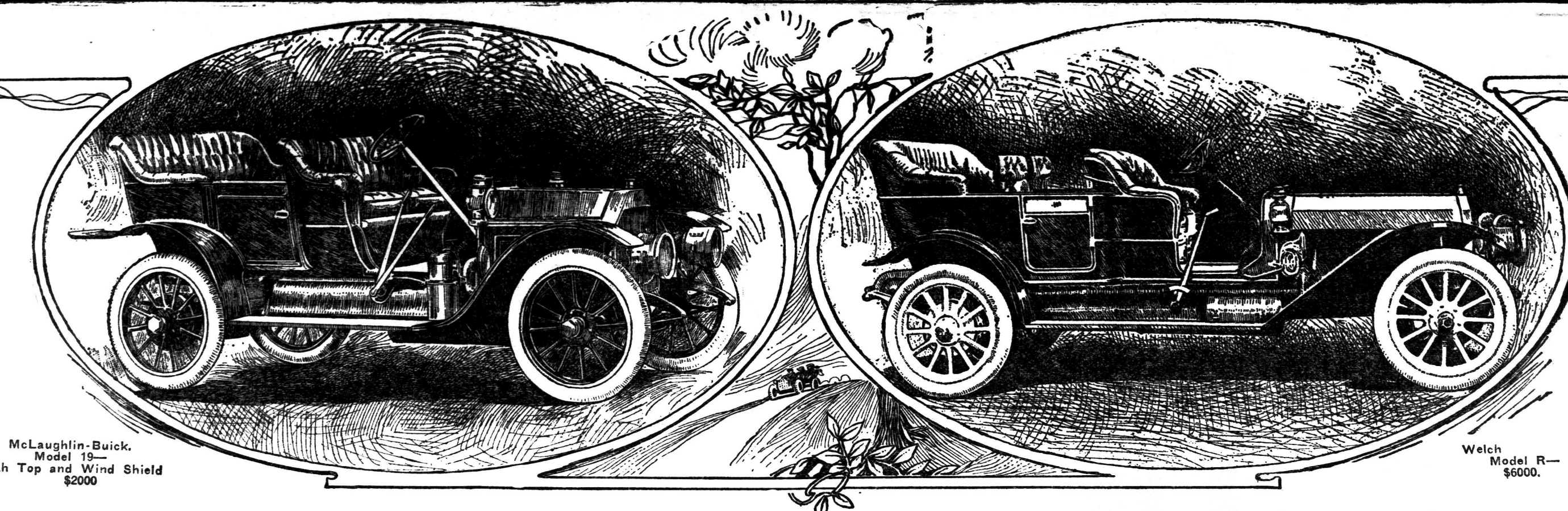

CONFUSION OVER KINDERGARTENS

Board of Education Are Puzzled to Know Just Where They Stand in Matter.

COMPELLED TO ADJOURN

Chairman Westervelt Will Ascertain if Motion to Have Double Sessions Was Legal.

After an hour and a half's debate on the kindergarten question the board of education, at a special session held yesterday afternoon, adjourned without taking any definite action. The chairman wished to be sure as to certain rules of order, and asked an adjournment on that ground. The session will be continued when he learns the law on the matter.

When the board met Secretary McElheran read three communications on kindergartens. The first was a petition from the kindergarten teachers of the city asking the board to reconsider the question. It was as follows:

"To the Chairman of the Board of Education:

"Dear Sir,—We, the directors and assistants of the kindergarten staff have received a notice from the secretary of your board to the effect that on or before the 22nd inst. we must apply for re-appointment. In addition to that we have read in the public press that at least one of our number has been dismissed. This, no doubt, is a little premature.

"Now, sir, this is a very serious matter, not only on account of the threatened dismissals, but because of the indignity placed upon our professional standing.

"It is not generally known to the trustees that nearly all the directors in your employ started at very low salaries, some at 40 cents a day, then 50 cents, followed by an advance to 75 cents, then to \$1, then to \$2.25 per annum, and so on until very recently the salaries were made such as would respectably support us. After all these years of hard work during which we have contributed in some degree towards placing the kindergarten system of London in its present good position, we are told that it is not carried on satisfactorily.

"We have never spared ourselves in trying to do our best, and we feel, and we know, sir, that you, as a teacher, will agree that the treatment proposed to be meted out to us is not such as would commend itself to the citizens generally.

"As to the hours we work, a reference to the rules of the board of education will show that the statement that we work but half a day is not correct.

The hours. "The kindergarten teachers who have morning classes average 4 1/2 hours per day, and the teachers of afternoon classes 4 hours per day (9-1:30, 12:30 to 4:30) in the kindergarten. Apart from this they have their Froebel Society, their Mothers' Club, programme or committee meetings, and make an average of nine or ten calls per month.

There are also occasional conferences of directors, or assistants, with the supervisor, and the directors give an occasional lecture to the students in training. This may require only an hour or so to give, but it requires much time in preparation. In addition to this the kindergarten teachers have had many study classes with outside specialists, including courses in brush work, clay, physical culture, music and folk games. These classes have been paid for partly from the proceeds of the public lecture courses by Dr. Moulton, Prof. Earl Barnes and others. More than a thousand dollars have been spent by the kindergarten teachers in this post-graduate work in the city during the past ten years.

"For the past month the kindergarten teachers have been spending one-half a day per week in the primary rooms of the city that have no kindergartens attached.

The Financial Side. "As to the financial part of the question we do not wish to speak. What we ask is that your board will reconsider the proposal and arrive at a conclusion which will not, to a large extent, destroy the usefulness of our splendid kindergarten system, and be a very great reflection on your kindergarten staff.

Teachers' Guild Protest. The next was a protest from the Woman Teachers' Guild, which was as follows:

"To the Chairman and Members of the Board of Education, London:

"Gentlemen,—Because of the excellent work being done by the London kindergartens, the inspiration and stimulus they are giving to the educational interest of our city, the service they are rendering to the intellectual needs of our citizens, because of the special work done by the kindergarten supervisor, Miss Laidlaw, who has made a life study of her work, travelling at her own expense through Canada, the United States and Europe, to bring back to her assistants and pupils all she could glean for their improvement, and the whole of education generally, and whose withdrawal from the city at this juncture would be an irreparable loss, we, the members of the Woman Teachers' Guild deeply regret the recent action of the board in asking the resignation of this trusted and tried body of women, since such action implies a lack of confidence or lack of efficiency or both, in the teachers so asked.

Dead Timber, Eh? "Further, we regret that a catch term, such as 'dead timber,' should have been used (as was reported), applied to this or any body of teachers, because such a term being reported in the press, is very readily taken up by the unthinking public, and incalculable injury to a teacher's reputation results.

"We trust that even yet there may be a more just solution of the question than an action which would send those not re-appointed from the service of the board with the stigma of dismissal, and with this opprobrious epithet clinging to their reputations as teachers.

The third was the proffered resignation of Miss Laidlaw, kindergarten supervisor, already published.

On motion of Trustee Tensdall, the petitions were received and placed on record.

The Board's Attitude. Trustee Graham took up the question of the board's attitude to the criticisms levelled at them because of the motion passed at the last meeting to work double sessions.

A great deal of mistaken information has been given out regarding our action," said Mr. Graham. "The most of the letters in the papers are wholly based on misinformation. The question of Miss Laidlaw's resignation was never discussed at the board. The Guild has apparently taken a view of the matter not at all in keeping with the facts. We simply looked at the question in a business way. We concluded that the teachers could work two sessions a day, for which we would pay them the same salary as other teachers, an increase over what they are getting now, and by this method save the citizens a great deal of money.
