Three other projects in the area of economic and human resource planning are currently well into implementation phase and are scheduled to wind down in 1991. These are the Human Resource Planning Project, a \$3 million initiative to assist the Malaysian government in the planning and evaluation of human resource development programs; the Second Industrial Training Project, which involves \$4 million in CIDA funding (of a total project multinational contribution of US\$125 million) to assist the Government of Malaysia in the training of technicians and skilled industrial workers; and a \$1.2 million project to assist in the development of the recently established Malaysian Institute of Economic Research. A second phase of this latter project is currently being developed.

In the agriculture sector, the Agriculture Information Systems Project, currently at mid-point in its implementation, is designed to assist the Government of Malaysia in optimizing the use of agricultural land by upgrading the land evaluation capabilities of the Department of Agriculture.

Two other projects are planned in this sector. The first is intended to assist in the preparation of a development plan and strategy for the optimal utilization of human and natural resources in the agriculture sector in the state of Sarawak. The second is designed to assist Malaysian institutions in carrying out monitoring, control and surveillance operations in the Extended Economic Zone.

4.2 Special Programs and Multilateral Contributions

Substantial co-operative linkages exist between Canadian and Malaysian non-governmental organizations and institutions through programs offered by CIDA's Special Programs Branch. Approximately \$0.51 million was made available in 1987/88 for projects in Malaysia, primarily in the sectors of education and institutional support and management. Contributions made to a number of established
