additional ounce or fraction thereof; second class matter (newspapers and periodicals) when mailed by the public—1 cent per 4 ounces or fraction of 4 ounces to each separate address; when mailed from the office of publication or from newsdealers to subscribers—4 cents per pound.

#### Parcel Post

30 cents per lb. or fraction of a lb.—Bitumount, Camsell Portage, Embarras Portage, Fond du Lac, Fort Chipewyan, Fort Fitzgerald, Fort Smith, Stony Rapids.

70 cents per lb. or fraction of a lb.—Fort Providence, Fort Resolution, Hay River, Port Radium, Rae, Yellowknife.

\$1.20 per lb. or fraction of a lb.—Coppermine, Fort Good Hope, Fort Norman, Fort Simpson, Norman Wells, Wrigley.

\$1.40 per lb. or fraction of a lb.—Aklavik, Arctic Red River, Fort McPherson, Port Brabant, Reindeer Depot.

Note: Small parcels weighing up to 8 ounces may be prepaid at the air letter rate of 7 cents for the first ounce, and 5 cents each ounce after, if the sender so desires.

(2) Yes. All mail for Yellowknife and the other offices mentioned above must be carried by air. Special rates of postage were established for printed matter, parcels, and news-
