While I do not propose to make a lengthy statement, I should like to say that although the estimates of the Department of Resources and Development for 1950-51 show an increase of \$19,081,710 over the previous year, a review of these estimates shows that they include a few new items authorized by statute or made necessary as a result of Canada Highway Act, \$20 million; administration of Trans-Canada Highway (increase), \$286,695; trans-Canada highway through Banff and Yoho national parks, \$25,000; to recoup Minister of Finance for advances made to Northwest Territories Power Commission, \$30,000. Deducting these items, there is an actual decrease of \$1,259,985 in the normal estimates of the department.

It has been necessary to ask for an increase in several of the votes, while in others we expect to be able to get along with a lesser amount than that provided in the previous year. With the reorganization of the departments of mines and resources and reconstruction and supply into three new departments near the end of a fiscal year, it has been difficult so to divide the votes for 1949-50 that an accurate comparison of appropriations may be had. Consequently some of the increases are more theoretical than actual. However, I shall be glad to explain the reasons for these increases and decreases as each vote is under consideration.

As we come to the votes for Central Mortgage and Housing Corporation and the national film board I shall make separate statements.

Mr. Adamson: Does the minister wish to discuss the Central Mortgage and Housing Corporation now, or leave it until the particular item is called?

Mr. Winters: I think it would be preferable to leave it until we come to the item.

Mr. Bryce: I want to take up the question I asked the minister a few minutes ago on the orders of the day. The minister said that the houses in the flooded area in St. Boniface, Manitoba, owned and operated by Central Mortgage and Housing Corporation would be put in shape by that corporation.
