AIR TRANSPORT

PACIFIC WESTERN AIRLINES—INQUIRY AS TO PAYMENT OF SUBSIDY

On the orders of the day:

Hon. Lionel Chevrier (Laurier): I wish to direct a question to the Minister of Transport and ask him whether the government has decided to pay a subsidy to Pacific Western Airlines?

Hon. Leon Balcer (Minister of Transport): The government has approved financial assistance to Pacific Western Airlines to cover direct losses incurred on the route from Edmonton through North Battleford-Prince Albert-Saskatoon to Regina. This relief is on an interim basis, and the matter will be considered further when the air transport board makes recommendations following completion of the series of hearings on regional air services which it is at present conducting.

Mr. Chevrier: May I ask in what amount it will be?

Mr. Balcer: The amount involved is \$25,000 and it is to cover the direct operating losses on the route. It is up to a maximum of \$25,000.

AIRPORTS

SAULT STE. MARIE, ONT.—CALLING OF TENDERS FOR TERMINAL BUILDING
