#### CRIMINAL CODE

## AVAILABILITY TO ACCUSED OF RESULTS OF INVESTIGATION

Mr. M. L. Klein (Cartier) moved for leave to introduce Bill No. C-205, to amend the Criminal Code (right to inspect).

# Some hon. Members: Explain.

**Mr. Klein:** Mr. Speaker, the object of this bill is twofold; first, that all the facts and evidence of a criminal investigation of an accused prior and subsequent to his arrest be made available to him before trial and that such investigation be carried out for the crown and for the defence; second, that any crown attorney or any officer of the crown be deemed guilty of a criminal offence who knowingly withholds evidence which could contribute to the proof of innocence of an accused.

Motion agreed to and bill read the first time.

#### AMENDMENT TO ELIMINATE ATTEMPTED SUICIDE AS OFFENCE

**Mr. M. L. Klein (Cartier)** moved for leave to introduce Bill No. C-206, to amend the Criminal Code (attempted suicide).

#### Some hon. Members: Explain.

**Mr. Klein:** Mr. Speaker, the object of this bill is to eliminate a criminal offence the commission of which can only be committed by a sick person. The purpose of this bill is to eliminate the prosecution of a person who attempts suicide.

Motion agreed to and bill read the first time.

## VIET NAM—INQUIRY AS TO CANADIAN EFFORTS TO END WAR

**Mr.** David Lewis (York South): Mr. Speaker, I should like to address a question to the right hon. Prime Minister. In view of the statement by the Minister of Finance last night emphasizing what many of us have believed for a long time, that the present international monetary disturbances are due mainly to the war in Viet Nam, what new initiative is the government planning to take or to promote in order that this disastrous war may be brought to an end?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I do not think any government, apart from those directly concerned with this war, has taken more initiatives and attempted to do more to bring this tragic war to an end than the Canadian government. We will continue to do what we can.
