ADVICE TO WHEAT GROWERS ON PRODUCTION

When does the minister intend to offer meaningful production advice to farmers so that they may reduce their wheat production without producing a surplus in other crops, a possibility suggested in a statement made to the Canadian Federation of Agriculture?

Hon. Otto E. Lang (Minister without Portfolio): It was also stated yesterday that we were very conscious of the fact that time is pressing in this regard, and therefore we shall be making any advice we have to give on this subject available as soon as possible.

Mr. George Muir (Lisgar): Mr. Speaker, I have a question for the Minister without Portfolio. In view of the fact the minister is recommending that farmers with surplus wheat further reduce wheat acreage or grow no wheat this summer, is the government considering paying for this reduction in wheat acreage in order to compensate those farmers who follow his suggestion?

Mr. Lang: Mr. Speaker, the whole question of the kind of advice we should give to farmers and of the fashion in which we should try

to make that advice as meaningful as possible to individual farmers in order to achieve the right result is all part of the matter that is under consideration. In addition, may I say that the word "recommending" used in the hon. member's question is probably slightly mis-stating the situation, since what I was really doing was asking some logical questions in light of the current situation.

Mr. A. P. Gleave (Saskatoon-Biggar): Mr. Speaker, I have a supplementary question for the Minister without Portfolio in charge of the Wheat Board. In view of the minister's advice to western farmers not to plant wheat in the current crop year, are we to assume that the Prime Minister's remark in Winnipeg, "why should I sell wheat" has now become government policy?
