Mr. Speaker: Order, please. I wonder whether hon. members might not agree that this is a restatement of the first supplementary asked by the right hon. gentleman?

Mr. Trudeau: Mr. Speaker, there was a substantially new element in that question and I wonder if I might be permitted to reply to it. It is the suggestion that we have to do something for the west. Surely, the right hon. gentleman realizes that the announcement made by the minister responsible for the Wheat Board, the Minister of Justice, is to the effect that the western farmer will now be permitted to get world prices for the wheat he sells to the miller, instead of the price he got earlier. I see the right hon. gentleman laughs, but he obviously does not understand this.

Some hon. Members: Hear, hear!

Mr. Diefenbaker: Mr. Speaker, I would have expected that applause. While the gabbling of geese saved ancient Rome, I doubt whether that type of thing will save this government.

Mr. Speaker: Order, please. Perhaps the debate might end at this point and we might return to the question period. I will recognize the hon. member for Kingston and the Islands in a moment on a supplementary to the previous question. The Chair will recognize the hon. member for Meadow Lake.
