LACK OF ACCESS FOR HANDICAPPED—CALL FOR INVESTIGATION—MOTION UNDER S.O. 43

Mr. Ian Waddell (Vancouver-Kingsway): Mr. Speaker, today I invited to the House of Commons a group of handicapped people from British Columbia. They came in their wheelchairs and were at first unable to get into the building. Eventually they got in through a side door which had to be unlocked. For a while they were unable to enter the parliamentary dining room; we had to carry them down the stairs.

Finally, not all of them were able to get into the House of Commons, though there were only about seven or eight of them in wheelchairs. The marble staircases pose a danger. One has to carry people into the galleries. The situation is really shocking. I would move, seconded by the hon. member for Vancouver East (Mrs. Mitchell):

That this House notes the difficulties handicapped people face inside the Parliament Buildings and urges the appropriate authorities to investigate these facilities with a view to suggestions for correction.
