CAUSES OF DECLINE IN EXCHANGE VALUE OF DOLLAR

Mr. Raymond Garneau (Laval-des-Rapides): Mr. Speaker, I wonder why the Canadian dollar continues to decline, if the Budget is so well received outside Canada. This week, an influential magazine, *Business Week*, commented that in the last twelve months there was a net outflow of five billion dollars, in addition to a drop of 2.5 billion in foreign investment in Canada. My question to the Minister of Finance is as follows: How can he blame the drop in value of the Canadian dollar on just a couple of speculators in Chicago, while the facts indicate that since early 1985, there has been a net outflow of capital from Canada to other countries?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, we have gone over this one before. I just want to draw to the Hon. Member's attention again, for about the fourteenth time, that it is important to understand what is happening in the broad economy. Investment activity in 1985 picked up after four years in the doldrums when investment activity was going down or staying level.

LOSS OF FOREIGN INVESTMENT IN CANADA

GOVERNMENT'S RESPONSE TO COMMITTEE REPORT

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, indeed, we have made progress. We have brought in Bill C-62. It is the first time employment equity has ever been addressed by the Government.
