INDICT MAN OF FILM THEFT.

ON COMPLAINT BY W. H. HAYS

New York, Aug. 19.—On the charge of receiving stolen motion picture films William E. Burns, an investigator, was committed to the Tombs by Judge Morris Koenig in general sessions, following the return of an indictment. District Attorney Banton said that the arrest of Burns, in Palisville, Ohio, was the first in a round-up of alleged traffickers in stolen reels.

The Indictment against Burns

was based on a complaint to the District Attorney by Will H. Hays, head of the motion picture industry, who was said to have complained that films stolen here had been shipped to Cuba and to South American countries and there sold.

The charge against Burns

came about as the result of a confession by three boys formerly employed by the Prudential Film Company, of 727 Seventh avenue, who were said to have implicated Burns in the theft of 1,000 feet of film.

Left Power on Electric Iron

and \$1500 Fire Resulted.

Ottawa, Aug. 19.—A \$1,500 fire, caused by an electric iron being left with the power on while the family were out of the house, occurred at the home of Max Kohl. The iron was left on a garment.

The damage was \$1,000 to the contents. There was no insurance.

TALKED FOOTBALL TOO EARNESTLY

And Now Reggie, Minus \$850, Is Picking Fruit and Planning Vengeance.

Somewhere in the Niagara Peninsula, where the peach trees are drooping beneath their luscious loads, Reggie Kease, late of Brandon, Man., is meditating dire vengeance upon a smooth stranger of Winnipeg "who done him wrong."

It was a prize hard-luck story which Reggie unfolded yesterday afternoon at the government employment bureau. Some two or three weeks ago he was all ready to leave the old country. His sick and aged mother had summoned her sons across the Atlantic, and Reggie had purchased railway tickets and transportation from Montreal.

But at Winnipeg, where he stopped off for a day or so en route, the villain of the story entered in the person of a genial young stranger. Reggie had been a football player of repute in Brandon, and the stranger, found by a little flattery a short road to the athlete's confidence.

That night Reggie woke up suddenly, feeling that someone had been in the room. But the visitor had departed—so had the pocketbook from Reggie's coat, containing the tickets and \$850 in cash. Reggie thinks that his new found friend entered by the front door or through the window from the veranda. A few days later the tickets were returned to Reggie by mail. Reggie's "friend" was arrested, but as the money was not found upon him and Reggie had no proof, he was released.

Meanwhile Reggie came on to Toronto, and although he is compelled to abandon his trip across the ocean, he went across the lake last night to join the peach-picking army. In a month or so he hopes to have earned the equivalent of the fare back to Winnipeg. And then he intends paying a call upon the young stranger who was so enthusiastic about football.

PROBE POISONING

OF FIFTEEN FOXES

Animals Were Valued at \$800

To \$1,000 Pair.

Kinston, Aug. 19.—Superintendent Joseph Rogers of the provincial police force has begun an investigation into the alleged poisoning of fifteen young foxes of the Catarqui Silver Fox Farm, and after hearing several witnesses adjourned the inquiry until the 25th. Dr. A. C. Neisch, professor of chemistry at Queen's, told of examining the stomachs of three of the foxes and finding phosphorus in considerable quantities. Rat poisons, he said, generally contained phosphorus. The evidence disclosed that detectives who had been working on the case discovered, several days after the poisoning, two boxes of rat poison at the home of Floyd Aylesworth, one of the owners of the farm, but no explanation was forthcoming as to how it got there.

Two days before finding the poison, the detectives had searched the house and the poison was not there at that time. The poisoned animals were valued at from \$800 to \$1,000 a pair.

MONTREAL CONCERN

BARRED FROM MAILS

U. S. Post Office Issues Fraud Orders Against Silverware Companies.

Washington, Aug. 19.—The Post Office Department has issued a fraud order against the Grand Silverware Company, the Imperial Silverware Company and the Prize Silverware Company of Montreal, Canada.

The three companies are believed by officials of the department to be one and the same company. They have been conducting a fraud for some time, offering prizes to persons solving intricate puzzles correctly.

A long string of fraud orders had been issued against silverware companies operating out of Montreal during the past six months. All have promoted through the United States mails and identical the same scheme as the three companies which were denied the further use of the mails. The list contains the names of sixteen different companies.

REVOLVER DROPS

WOMAN IS KILLED

Staten Island Patrolman Says He Dropped Gun When She Ticked Him.

New York, Aug. 19.—A bullet from a patrolman's revolver, which he says was accidentally discharged, killed Mrs. Pauline Ge Lerce, twenty-six, yesterday, in the back yard of her apartment at 105 St. Mary's avenue, Rosebank, Staten Island. The patrolman, a rookie, is Carmine Congo. He says that he unintentionally dropped the gun, causing it to go off. He lives with his mother and brother in an apartment below that of the dead woman.

Carmine was appointed a patrolman May 1 and attached to the Tottenville, S. I., police station. He told the police that the accident occurred while he was cleaning his revolver. Shortly after noon, he said, he sat down on a bench in the yard to examine the gun, and while there Mrs. Ge Lerce, who was on friendly terms with his family, joined him. Congo said the woman began to tease him and finally tickled him in the ribs. It was then he dropped the gun, he said, which was discharged as the trigger struck the ground. The bullet struck Mrs. Ge Lerce in the abdomen and she died before the arrival of a physician.

Congo immediately telephoned to the Stapleton police station, and he was placed under arrest. When arraigned before Magistrate William Crook in the Stapleton police court he was held without bail on a charge of homicide for further investigation. Shortly afterward Commissioner Enright suspended him. District Attorney Joseph F. Malloy began an investigation and had the accused patrolman enact the whole scene.

Congo's mother, who was the only witness of the shooting, was prostrated and unable to give an account of the

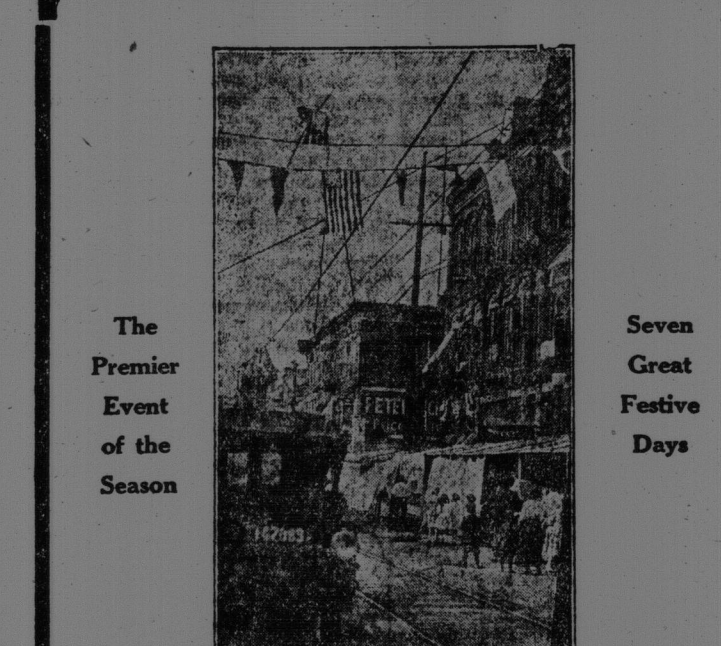
