"FREE TRADE BRITAIN"

Financial and Fiscal Heresy Do Not Find a Home Within Its Shores, Declares Walter Runciman.

Glasgow, Nov. 18.—Walter Runciman, financial secretary of the treasury, delivered an address here tonight in which he said that amid the financial turmoil in America, free trade in Great Britain rode on anxiously but financially triumphant. Britain was the only safe spot, he continued, because financial and fiscal heresy did not find a home within her shores. At the same time financial disaster in America must bear fruit on this side, for Great Britain's international trade was nervous and closely connected with that of the United States.

"When that depression comes," the speaker said, in conclusion, "we will have nothing to do but to stand by the financial heresy and the heresy of the American people."

MAURETANIA'S SPEED

AVERAGES 24 5-8 KNOTS

Quebec, Nov. 18.—The Cunard liner Mauretania, which left Quebec at 11 o'clock yesterday morning on her maiden voyage to New York was 300 miles west of Brown Head, at two o'clock this morning. The distance from Quebec to Brown Head is 70 miles and therefore the Mauretania at two o'clock this morning had covered 230 miles. Leaving Quebec at 11 o'clock yesterday morning, an average of about 24 5-8 knots.

AMERICAN CONCERNS

ON SHORT TIME AND REDUCTION OF WAGES

Little Falls, N. Y., Nov. 18.—Notice was given today that the Robert MacKinnon Knitting Mills, the largest in the Mohawk Valley, would be operated only three days a week during the immediate future. The company announced a reduction of ten per cent in the wages of its employees, to take account of a short time schedule. Three hundred and thirty-five employees of the company, including the Richards mine in New Jersey. A similar reduction has been announced at the mines and works of the Empire Iron & Steel Company, and at the John Wharton blast furnace and mines in the houses in which he used to be master, and is made welcome and treated as a guest for weeks at a time. This is probably the latest family arrangement in the Middle West.
