

And objection being taken, that the Bill was out of Order, inasmuch as it affects the Public Revenue, Mr. Speaker decided, that the Bill was out of Order, and should have originated in a Committee of the whole House.

The Order of the Day for the second reading of the Bill, from the Legislative Council, intituled, "An Act to enable *Hugh Burgess* to obtain a Patent for certain new and "useful improvements," being read;

The Bill was accordingly read a second time; and referred to the Standing Committee on Miscellaneous Private Bills.

Then, on motion of the Honorable Mr. Attorney General *Macdonald*, seconded by the Honorable Mr. Attorney General *Cartier*,

The House adjourned:

Mr. *Mackenzie*, from the Joint Committee of both Houses on the Subject of the Printing of the Legislature, presented to the House the Sixth Report of the said Committee, which was read, as followeth:—

The Committee have carefully examined the document referred to in the following Motion for Printing, and recommend that it be printed, viz.:—

By Mr. *McMonies*,—Statement of the Officers and Servants of the Legislative Assembly at the time of the removal from *Quebec* to *Ottawa*.

The Committee also recommend that the following documents be not printed, viz.:—

Return to Address,—Certain correspondence with Mr. *Richard Pope*, Mining Agent at *St. François de la Beauce*.

Return to Address,—Relative to claims of Advocates, within a certain period, representing the Crown in Court of Queen's Bench.

Return to Address,—Correspondence, &c., in reference to the levying and collecting of tolls on the *Burlington Bay Canal*.

Return to Address,—respecting certain operations of the *Montreal Harbor Commissioners*.

Return; shewing what publications have been entered in the Provincial Registrar's Department, under the Copyright Act.

The Committee also recommend that the following document be printed in the English language, and for distribution only, viz.:—

Return to Address,—shewing amount of money expended by the Government to the present time on the *Port Stanley Harbor*, and on the *London* and *Port Stanley Gravel Road*.

The Committee also beg to recommend that, in the view of the next Session of Parliament being a Session of the Confederated Provinces, a sufficient number of the Departmental Reports, which are usually submitted to Parliament, be printed for the use of the Federal Legislature, as well as the Local Legislatures of *Upper* and *Lower Canada*; such numbers to be computed on the same scale, numerically, as at present.

The Committee having had under their consideration that portion of the First Report of the Select Committee appointed to assist Mr. Speaker in the direction of the Library of Parliament, so far as the interests of the Legislative Assembly are concerned, and to act as Members of a Joint Committee of both Houses on the Library, which referred to the expediency of authorizing the compilation of a General Index to the Journals of the Legislative Assembly, from the year 1852 to the close of the present Parliament; and which, when completed, was recommended to be printed and distributed under the direction of the Speaker and the Printing Committee. The work being now nearly completed, the Committee have made arrangements for the printing and distribution, for which purpose
