

above all, to the quality of his officers. Turkey is certainly less extensive than Russia, but it possesses a population probably no smaller than that of France, and peculiarly available for the requirements of an army.

Of course, there would be some difficulty in thus combining European with Asiatic elements, nor would the operation exactly resemble our own proceedings in Portugal, or Napoleon's arrangements in the Italian States.

It would be very desirable to see the day when a Turkish division may be reconnoitred as a matter of course, a march for a Russian division of equal strength; nor does there seem much reason why such a commensuration should not be brought about.

In the forthcoming campaigns we shall have the option of two plans. We may either treat the Turkish army as little account, and rely upon the British and French contingents for the shock of battle, or we may endeavour to make the Turkish forces as steady and servicable as our own.
