### WORKING PAPERS, NORRIS COMMISSION

Motion No. 9-Mr. Orlikow:

That an order of the house do issue for copies of all the working papers prepared for the Norris commission by the chartered accountants hired by the commission and deposited by Mr. Justice Norris with the Department of Labour.

Hon. J. R. Nicholson (Minister of Labour): Mr. Speaker, a similar motion appeared on the order paper during the last parliament. When it was called, my immediate predecessor as Minister of Labour indicated that to accept this motion would involve a disclosure of working papers of the commission, and this is contrary to customary practice, because it would also involve a disclosure of confidential internal operations of several trade unions. My observation in this case in reference to motion No. 9 would be identical to that of my predecessor. I therefore respectfully suggest that the hon. member consider withdrawing the motion.

Mr. David Orlikow (Winnipeg North): Mr. Speaker, when I raised this matter last session I received the answer that the minister has just given. I said then, and I repeat now, that obviously a reporter for the Toronto Star had access to those documents, that very large extracts were printed in the Toronto Star which made very serious allegations against various people, and I did not think that members of parliament should be second class citizens behind newspapermen. I would therefore request that this motion be put down for debate.

## CORRESPONDENCE BETWEEN C.B.C. AND MAURICE SAUVÉ

#### Motion No. 12—Mr. Keays:

That an order of the house do issue for a copy of all correspondence exchanged between the C.B.C. and Maurice Sauvé, electoral candidate, prior to the general elections of 1962 in relation to a decision respecting French television services in the Iles de la Madeleine, P.E.I. and Nova Scotia.

Hon. Judy V. LaMarsh (Secretary of State): Mr. Speaker, any correspondence of the kind referred to in notice of motion No. 12 would be the property not of the government but of the individual who wrote the letter and of the corporation. Consequently it could not be produced by the government. I understand, however, that Mr. Sauvé, who is now a member of this chamber, is quite willing to table any such material which is his private correspondence. That being the case, I ask leave of the house to table correspondence dated April 21, 1962, and May 2, 1962 between Mr. Sauvé and Mr. Alphonse Ouimet of the C.B.C.
