## ADMINISTRATION OF JUSTICE

BRITISH COLUMBIA—REFUSAL OF UNION OFFICIAL TO ANSWER QUESTIONS

On the orders of the day:

Mr. H. W. Herridge (Kootenay West): Mr. Speaker, I rise to address a question to the kindly Solicitor General with a great deal of righteous indignation because this matter is of national significance. In view of the fact that Mr. Orville Braaten, a respected trade union leader and a member of our party, was sentenced to jail for contempt of court and was walked off handcuffed for refusing to answer questions on the ground that the instructions from the Solicitor General placed time limitations on questions that could be asked in the inquiry, will the minister inform the house what he intends to do to correct this situation and whether he intends to be represented at any hearings questioning the validity of the public inquiries act of British Columbia?

Hon. L. T. Pennell (Solicitor General): Mr. Speaker, I am informed no reference was made to the Solicitor General before the commissioner by Mr. Braaten or his counsel in relation to the incidents which led to Mr. Braaten being cited for contempt. Furthermore, I or no one acting on my behalf issued instructions placing general limitations on questions that could be asked at the inquiry, nor would I have any authority to do so. Under the circumstances it is not our intention to be represented at the proceedings now before the Supreme Court.

## NATIONAL DEFENCE
