PRAIRIE PROVINCES—ACTION TO IMPROVE NET FARM INCOME

Mr. Lorne Nystrom (Yorkton-Melville): I wish to direct my question to the Prime Minister. In view of the figures that have just been released by the Dominion Bureau of Statistics which show that net farm income in Saskatchewan has dropped by 56 per cent in the past two years and in view of the fact that bills before the House will do little to seriously alter that situation, is the Prime Minister contemplating any emergency action to try to improve the farm income picture in western Canada?

Mr. Speaker: Order, please. The hon. member will recognize that he has invited the Prime Minister, or someone on behalf of the government, to make a rather general statement. He might inquire whether such a statement will be made on motions in due course.

Mr. Nystrom: In that case, may I ask the Prime Minister if he will make a statement indicating whether he is planning any legislation to improve the farm income picture in western Canada in a serious way?

Mr. Horner: Call the by-election.

Right Hon. P. E. Trudeau (Prime Minister): As the hon. member for Crowfoot said a moment ago, there is a proposed sum of \$100 million in the offing, if the opposition can get on with the business of passing these bills.

Some hon. Members: Hear, hear!

Some hon. Members: Oh, oh!

Mr. Horner: I rise on a question of privilege. That legislation was first proposed in the House on October 29. Why did the minister not bring it in months ago? He did not have it drafted. We have not held it up.

Mr. Speaker: Order, please. I suggest to hon. members that during the question period we are now discussing legislation which is otherwise before Parliament. That is not in order.
