DISCUSSIONS WITH PROVINCES ON PLANNING OF CITY GROWTH TO AVOID NECESSITY OF COMMUTING BY AUTOMOBILE

Have there been any discussions between the federal government and the provinces, or any requests made by the provinces, regarding research into a logical way of controlling and planning city growth so that commuting by automobile on costly highways to and from suburbs will not be necessary in the future?

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, this is perhaps a special part of the consideration of the whole environmental problem being given by the minister responsible for urban affairs and Central Mortgage and Housing Corporation. This is a field of sociological research into which considerably more effort has been put in recent years than in the past, but I think we are still some distance from finding the answers.
