# SUPPLY AND SERVICES—SECURITY DEPOSITS

# Question No. 3,249-Mr. Reynolds:

1. In the past five years, how many companies have refused to tender with the Department of Supply and Services because they were required to deposit securities by way of certified cheque?

2. Would the Minister indicate the necessity of security deposits realizing that at times firms have been reluctant to tender because of lengthy holdbacks on the return of security capital?

Hon. Jean-Pierre Goyer (Minister of Supply and Services): 1. As was indicated in the reply to question 1,996, security deposits are seldom required. Therefore, the Department does not record the number of companies who have refused to tender because they were required to deposit securities by way of certified cheque.

2. Pursuant to Part VI, Section 39 of the Government Contracts Regulations, security deposits are required only when it is considered essential as a means of ensuring that a bidder will accept a contract if he is the successful tenderer.

## Question No. 3,296-Mr. Forrestall:

1. What progress is being made towards establishing a rail commuter service between Windsor Junction and outlying areas and the metropolitan community of Dartmouth and Halifax?

2. On what date will a final decision be known?

Hon. Otto E. Lang (Minister of Transport): 1 and 2. On July 30, 1975 the government announced a Capital Assistance Program to Commuter Services. Under this program the government of the province and the municipalities concerned after agreeing to an urban development strategy would apply for assistance to implement a commuter service in support of such a strategy. Since the initiative for proposing a commuter service between Windsor Junction and outlying areas and the metropolitan community of Dartmouth and Halifax rests with the province no decision will be made until an appropriate application is received and approved.
