*DEPARTMENT OF NATIONAL REVENUE—INSTALLATION OF COMPUTER, WINNIPEG

Question No. 2,946-Mr. McKenzie:

- 1. Is the Department of National Revenue planning to locate a computer centre in Winnipeg and, if so, will the Department or the Department of Public Works be buying or leasing a building?
- 2. Is the CAE Air Canada building at 570 Ferry Road being considered and, if so, will it be bought or leased?
- 3. If the Department of National Revenue occupies the building will renovations be required and, if so (a) what will be their cost (b) who will pay for them?
- $4.\ {\rm For\ how\ many\ years\ would\ either\ Department\ lease\ the\ building\ at\ 570\ {\rm Ferry\ Road?}$
- 5. Did either Department advertise for tenders to lease or buy such building and, if so (a) who submitted tenders and in what amounts (b) was the contract to occupy 570 Ferry Road the lowest offer?
 - 6. Who are the owners of the building at 570 Ferry Road?
- 7. Will the computer operation be affected if jet aircraft are only a short distance above the building when landing?
- 8. Are any other new computer centres being planned and, if so, in which cities?
- Mr. J.-J. Blais (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, I am informed by the Departments of National Revenue and Public Works as follows: 1. The Department of National Revenue will open a Regional Data Centre in Winnipeg using some small scale computer equipment. The Department of Public Works will lease a building for that purpose.

- 2. The CAE Aircraft Building in Winnipeg will be leased to house the National Revenue Taxation Data Centre.
- 3. (a) The estimated cost of tenant services is \$1,760,000. (b) The cost of the tenant services will be the responsibility of the Department of National Revenue.
- 4. The DPW will lease the CAE Building for a term of three years. The lease will include three 1-year options on the same terms and conditions.
- 5. (a) The DPW advertised for proposals to lease approximately 100,000 sq. ft. of space in an existing building. One offer only was received from Metropolitan Estates Properties Corporation. The offer was disqualified as it did not meet the terms of the tender document which called for space in an existing building. (b) Due to the limited time frame available, offers for space in existing buildings were solicited and the proposal received from the CAE Aircraft for accommodation at 570 Ferry Road was the lowest.
- 6. CAE Aircraft Limited, Winnipeg International Airport, P.O. Box 1700, are the owners of the building at 570 Ferry Road. Located on a site leased by CAE Aircraft Ltd. from the Ministry of Transport.

- 8. Other Regional Data Centres are in the planning stage but no further cities have been selected as yet.

COMBINES INVESTIGATION ACT

AMENDMENTS RESPECTING DEFINITIONS, POWERS OF INVESTIGATORS, OFFENCES
