He is vice-president and director of Renzy Mines Limited, and secretary and director of Cleveland Twist Drill Carpet (Canada) Limited, Canadian Admiral Corporation Limited, and Canadian Klockner Limited.

Then there is one Denis K. Yorath who is on the board of directors of IAC as well as of the Montreal Trust Company, Dover Industries Limited, Howell Litho and Cartons Limited, Richardson Mernell (Canada) Limited, Wayne Sweeper Manufacturing (Canada) Limited. He is, in addition, governor of the Canadian Council on Social Development.

An hon. Member: That's interesting.

Mr. Rodriguez: Yes, that is very interesting. Then, Mr. Speaker, we have one Harry W. Hays, another Liberal senator. He is a director of the Burritt Travel Service Limited and of The Canada Permanent Trust Company. Then there is Mr. K. H. MacDonald, also on the board of directors of Canada Permanent Mortgage Corporation and on the board of directors of IAC.

An hon. Member: They don't talk to each other either.

Mr. Rodriguez: They don't? I guess that means they are on opposite sides of the Chamber. Then, lo and behold, we come to K. H. MacDonald who is also a director of that company and also on the board of directors of IAC. This K. H. MacDonald is the same fellow. He is also a director of the Home Oil Company Limited. Then we have Renault St. Laurent. He is on the board of directors of IAC and Lakeside Cattle Company Limited.

I understand that this chap Harry W. Hays, the Senator, is also a director of Lakeside Cattle Company Limited. Then, somehow or other, and I do not know how this gets in here but I suppose it is quite understandable, we have Senator E. C. Manning—

Some hon. Members: Shame, shame!
