SUGGESTED USE OF PRAIRIE FARM EMERGENCY FUND FOR RESEARCH PURPOSES—MOTION UNDER S.O. 43

Mr. Doug Neil (Moose Jaw): Madam Speaker, whereas an examination of the 1982-83 estimates tabled last week is an indication that the Minister of Agriculture gives little priority to research and development in agriculture and is more concerned about market development. I move, seconded by the hon. member for Bow River (Mr. Taylor):

That the Minister of Agriculture forthwith bring in legislation to make the \$9 million of producers' money held for the past ten years in the Prairie Farm Emergency Fund available to producers for research and development of cereal grains and oilseeds suitable for cultivation in the Canadian Wheat Board area or, alternatively, undertake to pay interest on the fund at current rates, which would amount to approximately \$4,000 per day, until such time as suitable research arrangements are made.

CRIMINAL CODE

CALL FOR INVESTIGATION OF GUN CONTROL SECTION AND OF EMERGENCY ORDER IN COUNCIL—MOTION UNDER S.O. 43
