

the Lieutenant-Governor, with the Resolution of yesterday, on the subject of the appointment of Commissioners for the new Government-House, that his Excellency had been waited on accordingly, and that his Excellency had delivered to the Committee a written answer as followeth :

" THE Commissioners appointed by me, for building a Government-House, pursuant to the Law made for that purpose, being fully competent to that duty, and not having signified to me any intention to relinquish the trust reposed in them, and having hitherto conducted themselves in that service to my satisfaction, I see no necessity for the appointment of any others ; nor if such necessity existed, should I think myself justifiable in consenting to any change or participation in the method of nomination established by Law.

Mr. Tonge reported from the Committee appointed to wait on his Excellency the Lieutenant-Governor, with the several Resolutions on the subject of erecting a Light-House on Briar Island ; that his Excellency had been waited on accordingly, and that he was pleased to assure the Committee that he would communicate with the Lieutenant-Governor of New-Brunswick thereon, and otherwise attend to the request of the House.

On motion of Mr. Tonge, resolved, that the further consideration of the Bill in amendment of the Act of the 37th year of the reign of his present Majesty, relating to the Public Buildings, be deferred to the next Session.

The Chairman reported from the Committee, that they had gone through the business to them referred, and that the Committee had come to several resolutions thereupon, on which the Committee had framed a Bill, for applying certain monies therein mentioned, for the service of the year 1802, and for appropriating such part of the supplies granted in this Session of General Assembly, as are not already appropriated by the Laws or Acts of the Province, to be delivered to the House, and he read the Report in his place, and afterwards delivered the Bill in at the Clerk's Table, where the Resolutions and Clauses therein contained were severally read throughout a first and second time, and thereupon Mr. Chipman moved, that the same be not agreed to by the House so far as they relate to the granting the sum of 1500l. for the service of the new Government-House ; which being seconded and put, and the House dividing thereon, there appeared, for the motion 12, against it, 18.
