This ground will le level with terraced banks for the bleachers and fringed by a fine grove of tall trees. Back from the grounds it is the intention to erect a dance pavilion with refreshment stands, etc. An orchestra will be employed, if verything goes right, and the place should be decidedly popular with city visitors during the summer nights, making a veritable "Coney, Island"


