In Saskatchewan a further outbreak is expected but the chief outbreak will apparently be in Alberta, in which province there was a heavy egg deposition in 1921, which it is expected will result in an important infestation of hoppers in 1922, particularly in the sections immediately north of the main line of the Canadian Northern railwav.
