### IMMIGRATION FROM GREAT BRITAIN

### Mr. KELLNER:

1. What contracts or agreements or undertakings at present exist for bringing immigrants into Canada, between the federal government or any department thereof, and the imperial government or any other government, concern, association, company, individual or individuals?

2. What inducements are offered to these immigrants, in the way of, (a) reduced transportation charges, (b) assistance to agriculturists, (c) protection against unemployment or any other considerations?

## Mr. FORKE:

1. (a) Empire settlement passage agreement which provides passage assistance to certain classes of immigrants; (b) 3,000 family settlement scheme; New Brunswick land settlement scheme, Nova Scotia land settlement scheme; boys' land settlement scheme and provincial reception and distributing farms scheme; (c) Railways agreement. All of the above mentioned schemes, except the railways agreement, relate solely to British immigrants.

2. (a) Agricultural families receive the following assistance: Those over 19 years of age are given third class ocean rate of £2 with corresponding reduced rail rate to destination in Canada. Children under 19 years of age belonging to agricultural families receive free transportation. British houseworkers receive the same passage assistance as adults belonging to the agricultural families. J venile immigrants coming to Canada under a provincial-federal scheme or under the auspices of an approved society receive free passage. The minimum and maximum age is fixed for juvenile boy immigrants as 14 to 19 years and of girls as 14 to 17 years. The wife and children under 17 years joining the head of a family settled in Canada prior to June 6, 1928, are given transportation assistance as follows: the wife, £3 third class ocean rate; children under 17 receive free transportation.

The above passage assistance is applicable only to British subjects ordinarily resident in Great Britain and northern Ireland.

(b) British families settled under the 3,000 family scheme, or the New Brunswick or Nova Scotia land settlement schemes, receive directional care and oversight. Funds to supply the families with stock and equipment
