Who have the floor should address the Speaker, 519-20

## Motions

Adjournment, for, under standing order 31, leave refused, 117-19

Amendment must delete or add certain words to main motion, 768

Coming in direct conflict with the oath taken by members of this house, not in order, 1879-80

Decision may be left to house in certain instances as to whether member may have leave to present motion. 767-68

For the production of papers, against rules to permit debate on, 2382

Government notices of motion for the house to go into committee at a later date, not debatable, 2106

Instruction, of, useless and irregular if subject-matter is within scope of question referred to the committee, 2502-03

May be spoken to only once, 1680-81, 2050

Production of papers, for, not debatable, 1530

Supply for, member may speak only once, 2293, 2376

Suspension of six o'clock adjournment, for, must have unanimous consent, 1402

Noise in the chamber. *See under this title*, Audibility of debate

Not the practice to permit a debate upon a statement made by a member of the government, 1380

Supplementary questions must be put without comment, 120

No opportunity for speaking twice on, as it is not a substantive motion, 1454

Not a substantive motion, therefore there is no reply, 1500

Remarks should be relevant to motions before house, 1450-51

## Privilege, questions of

Accusation made during may be replied to, 950

Debate on not permitted, 1532

May not start debate on, 950

Remarks should be confined to statement of, 949-50

Sanction, may be obliged to apply if member does not withdraw unparliamentary language, 2674-75

Speaker decides whether or not a member is in order, 1533

Speaker's ruling not debatable, 1005, 1581

Sustained on appeal, 117-19, 1766, 2113-14, 2625-26
