CAUSEWAY CONSTRUCTION, P.E.I.-N.B.

Motion No. 51-Mr. Robichaud:

For a copy of all correspondence, telegrams, and other documents exchanged from September 1, 1960, to date, between the federal government or any agency or department thereof, with the government of the province of Prince Edward Island, in connection with the construction of the proposed causeway across Northumberland strait to link Prince Edward Island with New Brunswick.

Hon. D. J. Walker (Minister of Public Works): Mr. Speaker, I shall be very happy to accept this order with the usual reservation; but to save the time of the house and for the information of the hon. member for Bonavista-Twillingate I may say that the usual reservation is that we are required under the rules of the house or the practice of the house to get the consent of the province. In this case it is the province of Prince Edward Island. Perhaps that statement will satisfy the hon. member for Bonavista-Twillingate.

Mr. Speaker: The minister has indicated that the motion is acceptable, subject to the limitation that the consent of one party to the correspondence, namely the province, be obtained before the order be filed. Subject to that reservation or limitation expressed by the minister, is it the pleasure of the house to adopt the motion?
