That, I think, should have been brought to be considered as to whether the bill presented motion? and read the first time is, in fact, legislation within the practices of the house. Hon. E. D. Fulton (Minister of Justice): I have to advise the house that I am not able to accept this motion because it calls for the production of documents which have always clearly been regarded as privileged, inasmuch as it asks for the production of documents exchanged between the government or any agency or branch thereof and any official or staff member of the penitentiary branch since January 1, 1958. I am not, therefore, able to agree to the motion. I would point out, however, that a copy of the inquest referred to was tabled in this house on April 28, 1960.
