plan can be operated for one year. The money would all be spent in Canada and for transportation on facilities already running. The centennial commission is now operating and no new body will have to be set up. Every parent who participates in the program will be making a personal contribution to the centennial and will be receiving something from it for his or her own child. Every person in every community can give something to the country in accepting and welcoming the visiting student.

May I conclude by saying that the centennial can become a meaningful experience so that when the bunting comes down, the buildings are emptied and a second look is taken at many of the centennial projects which are expensive and unproductive, there will be a deep satisfaction in knowing that we have taken a real step ahead, one that will be rewarding and permanent. May I call it ten o'clock?

Progress reported.

ADMINISTRATOR FOR TRAINING COLLEGE

Mr. Donald MacInnis (Cape Breton South): Mr. Speaker, it is regrettable that under the new rules, although hon. members are given an opportunity to put forward questions at this time, the responsible minister is not required to be present. Yesterday I asked the Minister of Transport a question, and I might say that his attitude was rather petulant, in fact ridiculous, in that he expected me to preface my question with a speech welcoming him back to the house, something he had already received from a member of the N.D.P. and a Conservative member.

I know, regardless of what prepared answer someone on the Liberal side may have to give me, it will not in any way, shape or form be a reasonable or accurate answer to the problem before us at this time. My question to the Minister of Transport was:

Was it necessary for the department to reach into the ranks of the retired to find an administrator for the proposed coastguard college at Point Eward?

Mr. Speaker, I do not mind too often remarks made in the house while members are sitting in the house, but I don't see why I have to put up with members behind the curtain making all this noise. I would very much appreciate a little order, especially from those standing behind the curtains.

In his answer to the question, the Minister of Transport in his usual, complete disregard for the truth had this to say—

Mr. McIlraith: Order.
