WHEAT-STORAGE FACILITIES IN IMPORTING COUNTRIES

BIAFRA-DESTRUCTION OF CANAIRELIEF MERCY AIRCRAFT

Mr. R. Gordon L. Fairweather (Fundy-Royal): Mr. Speaker, I have a question for the Secretary of State for External Affairs. I wonder whether the minister will answer the questions asked yesterday by my leader, and also my supplementary question, taken as notice by the Acting Prime Minister and concerning attempts by Nigeria to destroy Canairelief aircraft?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, when I returned this morning my attention was drawn to these questions. The position is as follows:

The Nigerian government has often made it clear that such flights would be entirely at the risk of those who made them, since arms deliveries continue from Sao Tome into the same airstrip at the same time as the relief aircraft. It is to avoid these risks and to permit an effective relief operation that the government hopes Colonel Ojukwu will agree to daylight relief flights into Uli and Obilago. In

Concerning the second part of the question. we have received expressions of concern from the Nigerian government as to the reported intention of Canairelief to establish an airstrip in rebel territory which, according to its promoters, is to be used exclusively for relief flights. With three known airstrips at least-Uli, Obilago and one near Uli/Ihiala-in the rebel area or a few miles away, none of which are now being used by day for relief deliveries, the Nigerian government obviously finds it difficult to see the justification for yet another airstrip to be built at great cost while present alternatives are ignored by the rebels.

DISCUSSION OF INITIATIVES AT TALKS BETWEEN PRIME MINISTER AND PRESIDENT NIXON

Mr. David MacDonald (Egmont): Mr. Speaker, may I address a supplementary question to the Prime Minister regarding some of the comments made by the Leader of the Opposition. I wonder whether the Prime Minister can inform the house if conversations were held with President Nixon about initiatives that the United States government has taken regarding relief shipments, and possible initiatives that the Canadian government might take with regard to relief.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the question of Nigeria was discussed by the President and myself but in rather general terms. As regards the United States position, I do not think I am in a position to make any comment.

Mr. MacDonald (Egmont): A further supplementary question. With regard to the second part of my question, could the Prime Minister indicate whether the President expressed to the Prime Minister any particular steps that our government might take with regard to assisting in the relief effort?
