LIVERPOOL, NOVA SCOTIA, HARBOUR—DREDGING OPERATIONS

Question No. 164-Mr. Crouse:

Is it the intention of the Department of Public Works to carry out dredging operations in Liverpool harbour, Queen's County, Nova Scotia, to increase water depths in the channel which crosses the harbour bar and, if so (a) what is the amount of funds set aside for this work (b) when will this dredging be carried out?

Hon. Arthur Laing (Minister of Public Works): No additional dredging is planned in this location at the present time. However, during the present fiscal year the mooring area behind the public wharf was dredged to a depth of 14 feet L.W.O.S.T. and the approach channel to the mooring basin to a depth of 11 feet at L.W.O.S.T. The total cost of this work was \$43,694.

DEPARTMENT OF FINANCE—NUMBER OF MAN-HOURS SAVED BY UTILIZATION OF COMPUTERS

Question No. 167-Mr. Robinson:

How many man-hours have been saved as a result of the utilization of computers by the Department of Finance during each year since computers have been used?

Hon. E. J. Benson (Minister of Finance): The provision of computer facilities in the Department of Finance has greatly increased the volume of analysis carried out on the national finances and the national economy. The work of compilation, storage, retrieval and analysis now being done by the computer would, if done by hand, require the services of a very large number of clerical staff, together with desk calculators, filing facilities, stenographic support and supervisory personnel. The computer permits the use of new and more advanced techniques of analysis, and provides a constant flow of up-to-date information of a kind which could not be provided by traditional means. No estimate of the man-hour equivalent provided by computer services is possible owing to the wide variety of new methods of data processing made possible by the use of the computer.
