ment's interest in the subject of unemployment, and in view of the fact that shipyards have had to lay off some of their shipwrights because the minister's department has not promulgated regulations with respect to the program announced over six months ago, will the minister make efforts to see that those regulations are promulgated so that the shipyards can get on with their work?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, I think my hon. friend is referring to the support for exports.

Mr. Comeau: No. I am referring to the program that was announced by the Minister of Fisheries and Forestry, which affects the minister's department.

Mr. Pepin: I have seen the regulations. I thought they had been issued. I shall look at this matter again.

## NATIONAL PARKS

WOOD BUFFALO AND GLACIER—TERMINATION OF LOGGING LEASES

Mr. Randolph Harding (Kootenay West): Mr. Speaker, may I direct a question to the Minister of Indian Affairs and Northern Development. Has the minister's department, in line with parks policy, tried to buy up or terminate the logging leases at present in force in Wood Buffalo National Park?

### [Translation]

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, these are the only logging rights in a Canadian national park. We do not intend at this time to buy them up since we are negotiating with the Alberta government with a view to exchanging this area for a region in southern Alberta which might well become a most interesting national park.

**Mr. Harding:** Mr. Speaker, has the department completed the buying up of timber berths in Glacier National Park?

### [Translation]

Mr. Chrétien: I am not sure, Mr. Speaker, but I think we have managed to buy back all logging rights in the national parks of the Rockies.

If we make an exchange with the government of Alberta, the latter should initiate the reforestation program in the park.
