apprised and aware of all objections by the provinces, if there are any, can the parliamentary secretary advise the House whether there have been further representations from the province of Quebec regarding any inadequacies or injustices within the present bill?

Mr. Ray Perrault (Parliamentary Secretary to Minister of Labour): Mr. Speaker, as the hon. member no doubt is aware, a series of important conversations have taken place between the Minister of Labour and the provincial Ministers of Labour this week. I will transmit to the Minister of Labour the concern expressed in the House this morning by the hon. member.

Mr. Alexander: Mr. Speaker, I am pleased to know that the parliamentary secretary will register my concern. Can the parliamentary secretary assure the House that before we deal with this bill in committee in a definitive way the minister will make a statement regarding the objections, submissions and representations made to him about the bill so that the committee will be aware of the specific problems being faced by the provinces? Can he assure the House that a statement will be made on motions before we deal further with this bill?

Mr. Perrault: Mr. Speaker, now that the measure has been given such substantial support by all members of the House—

Mr. Alexander: Could the parliamentary secretary not answer the question?

Mr. Perrault: —we are moving to the committee stage. At that point a full opportunity will be given to cross-examine the minister on these important points which have been raised. It is not the intention of the minister to avoid any possible problems that may arise. Matters are proceeding very well indeed.

Mr. Baldwin: Which way are you moving, forward or backward?

Mr. Alexander: Mr. Speaker, I quite appreciate the parliamentary secretary's answer although I accept it in the spirit in which it was given. I am asking the parliamentary secretary whether, on behalf of the minister, he can assure the House that a statement will be made regarding the positions taken by any provinces which have found objections within the bill. It is a simple question. Will a statement be made on motions before we deal with the bill?

Mr. Speaker: Order, please. Perhaps the parliamentary secretary might reply to the question briefly, but it seems to me that the hon. member has reiterated very forcefully the question that was asked initially.

Mr. Alexander: I have not been given an answer and I want an answer.

Mr. Perrault: Mr. Speaker, I can only say that this measure is proceeding in a spirit of co-operative federalism and it may be expected that such a statement will be made.
