had peripheral effects resulting in further unemployment in respect of other concerns which could not obtain supplies from companies that were on strike or supplies that were normally delivered by rail. One cannot expect that strikes, which are supposed to produce an adverse economic effect on the country, will not result in a statistical fall-out as well. This is exactly what happened.

Mr. Stanfield: If it is not the weather, it is something else, obviously. I should like to ask the minister whether this experience during the last six months since March— 5.5 per cent unemployment in March, seasonally-adjusted and 5.5 per cent seasonally-adjusted in mid-August, amounting to virtually no change as far as married men over 25 are concerned—corresponds with the hon. gentleman's definition of sustainable growth?

Mr. Turner (Ottawa-Carleton): I think sustainable growth is reflected by the fact that, as I have said, August over August, 464,000 new jobs have been created in this country. Despite the interpretation the hon. gentleman would like to place upon the figures, the trend of unemployment, discounting monthly variations, has been downward and is well below the figures last year.

Some hon. Members: Hear, hear!

## PROPOSED TAKEOVER OF ACKLANDS LIMITED BY UNITED STATES COMPANY—GOVERNMENT ACTION

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I have a question for the Prime Minister in the absence of the Minister of Industry, Trade and Commerce. It arises out of a report this morning of a United States takeover bid for Canada's largest wholesale automotive supply dealer in Winnipeg, Acklands Limited. In view of the employment implications in particular of this takeover bid, would the Prime Minister assure the House that the government is taking some steps at least to hold back this takeover bid?

Hon. Robert K. Andras (Acting Minister of Industry, Trade and Commerce): Mr. Speaker, on behalf of my colleague, absent on government business, and as Acting Minister of Industry, Trade and Commerce I would be glad to take the question as notice, study it very carefully, and give an answer to the hon. member.
