Mr. McGrath: In view of the continuing problems in this department with regard to the recently concluded agreement and the indication that a very small majority of the postal workers accepted the conciliation report, may I ask the minister when the government proposes to introduce amendments to this legislation since this matter does have a great deal of urgency?

INCREASE IN PRICES OF GASOLINE AND AUTOMOBILES— INVESTIGATION OF JUSTIFICATION

Are the minister and his department satisfied that these increases, which are a burden to millions of Canadians, are justified or is his office still investigating to find out whether action can be taken to protect this body of Canadian consumers?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): Mr. Speaker, if the hon. member is referring to possible action under the Combines Investigation Act, I am advised that the practice followed by successive governments is not to allude to the possible existence of an inquiry under the act unless such an inquiry has been terminated, unless the matter goes to the Restrictive Trade Practices Commission or unless there is some court proceeding.
