**NORTHERN AFFAIRS**

IMPLEMENTATION OF TASK FORCE RECOMMENDATION  
THAT NORTHWEST TERRITORIES COUNCIL BE GIVEN  
GREATER RESPONSIBILITY FOR HOUSING

**Mr. Doug Neil (Moose Jaw):** Mr. Speaker, my question is addressed to the Acting Minister of Indian Affairs and Northern Development. Would the acting minister tell the House when his department intends to implement the recommendation of a Northwest Territories task force that the housing responsibilities of the Northwest Territories Council be increased?

**Mr. Len Marchand (Parliamentary Secretary to Minister of Indian Affairs and Northern Development):** Mr. Speaker, I am not the acting minister but I will take that question as notice. The Minister of Indian Affairs and Northern Development has indicated in some public statements that by and large he agrees with the spirit of the task force report on housing issued by the Northwest Territories Council, though he had some reservations.

**Mr. Nielsen:** A point of order, Mr. Speaker.

**Mr. Speaker:** The hon. member for Yukon on a point of order.

**Mr. Nielsen:** Mr. Speaker, my point of order refers to the question just asked, relating as it does to a question of policy. It has been the practice, experience and tradition of this House that acting ministers are appointed to assume the responsibilities of ministers who are absent for lengthy periods or are ill. While we all regret the absence of the Minister of Indian Affairs and Northern Development, there is ample precedent in this government for the appointment of acting ministers. For instance, the Minister of Energy, Mines and Resources has acted on behalf of one of his colleagues in the past and similar examples can be given throughout the treasury benches. The parliamentary secretary, as able as he is, cannot answer questions calling for information about government policy; he is not a member of the cabinet and is not privy to their discussions. Surely we in the opposition are entitled to have an acting minister answer for the government on questions of policy.

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, may I ask a question of the Prime Minister, who indicated the other day, whether intentionally or not, that there was an Acting Minister of Indian Affairs and Northern Development. Would it be too much to ask that the House be told who the acting minister is?

**Right Hon. P. E. Trudeau (Prime Minister):** I will do that very gladly, Mr. Speaker. The acting minister is the Minis-
