various administrative buildings and additional stern loading facilities in a phased program over an eight year period.

3. The contracted cost of the study was \$43,000. The study was carried out by 13 professional/technical staff members of the consulting engineering firm and its Nova Scotia associates.

Hon. Mitchell Sharp (President of the Privy Council): The government does not maintain records which would enable it to trace the subsequent careers of those who at one time served ministers in the capacities listed. In order to answer this question, it would be necessary to review the personal files of every individual employed in the Public Service of Canada.
