REINSTATEMENT OF KATIMAVIK PROGRAM

Mr. Carlo Rossi (Bourassa): Mr. Speaker, I have here a number of petitions from residents of Sainte-Foy, Trois-Rivières, Quebec City, Charny, Lac-Beauport, Ville-de-Laval, Longueuil and Farnham, in the province of Quebec, as well as from Manitoba and Ontario, which, according to the Clerk of petitions, meet the requirements of the Standing Orders as to form. The petitioners ask the Government to reconsider its decision to cancel the Katimavik program.

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, I have a number of petitions from students of Ottawa and the surrounding area who ask that the Government take the situation back in hand and reinstate a youth program, either Katimavik or one like it.

I also have thousands and thousands of signatures in a number of petitions from La Promenade Secondary School in Hull, Quebec, asking that Parliament and the Government reconsider their decision, revise the Katimavik program and have it reinstated.

Mr. Speaker, I also have several petitions signed by people from Carleton University, Sir Wilfrid Laurier High School, and several other high schools in the Ottawa area, who petition the Government to reinstate full funding for Katimavik for the young people of Canada.

Finally, Mr. Speaker, I also have a petition from people residing on Daly Avenue and elsewhere in my constituency of Ottawa-Vanier asking that the Government reconsider its decision to cancel the Katimavik program and humbly pray that this Government reinstate the Katimavik program.

Mr. David Berger (Laurier): Mr. Speaker, I also have a petition concerning the Katimavik program. About a hundred people living in Orleans, Pointe-Gatineau, Cantley and Gatineau ask that Parliament reconsider its decision to cancel the Katimavik program. Those people point to the program's success in respect of youth training and the opportunity to become familiar with our country and its two official languages.

I also have another petition to that effect from the City of Longueuil, Brossard and Chambly on Montreal's South shore.

I have a third petition from the constituency of Drummondville, signed once again by about a hundred people who ask for the reinstatement of the Katimavik program.

CONTINUED OPERATION OF MORGENTALER CLINIC IN TORONTO—REMOVAL OF ALLEGED RESTRICTIONS ON POLICE

Mr. Bill Attewell (Don Valley East): Mr. Speaker, I have a petition from residents of the neighbouring riding of Don Valley West. It has been examined and found to be in order. The petitioners protest the continued operation of the Morgentaler Clinic in the City of Toronto. They call upon Parliament to require the Government of Ontario to remove any restrictions which may have been placed on the Metropolitan Toronto police force in regard to the laying of charges under Section 251 of the Criminal Code, and to express to the Government of Ontario the displeasure of this House at such lack of enforcement.

PRICE OF GASOLINE
