of Canada would take specific steps. In view of his experience in this House, the Hon. Member will know that when we deal with various countries on an international level, a number of factors must be taken into account. At present, with respect to the Turks, the Government of Canada is maintaining contacts. We have someone in External Affairs who has just returned from Turkey. We are attempting to, and hopefully will manage to solve the matter with the Turkish authorities, at the same time as we are preparing amendments to the refugee status that will soon be introduced.

The Hon. Member will have no difficulty appreciating that we are working on exceedingly delicate matters requiring a tremendous amount of attention, in view of the excessively open nature of our Canadian law with respect to the status of refugees.

ANNOUNCED CLOSURE OF CANADA PACKERS PLANT IN WINNIPEG

Mr. Bill Blaikie (Winnipeg—Birds Hill): Mr. Speaker, my question is directed to the Right Hon. Prime Minister or the appropriate Minister, the Minister responsible for DRIE, perhaps. My question has to do with the fact that the city of Winnipeg, which is still reeling from the CF-18 contract, the railbus business, et cetera, learned this morning that Canada Packers in Winnipeg will be shutting down its hog and beef kill

industry at the cost of some 475 jobs. What does the Government intend to do about this closure? Is the Government prepared to admit now that the kind of economic development policy it has in place for Manitoba is one whereby a \$1 million grant went to Neepawa and contributed to this closure? And will the Government adopt a coherent economic development policy for Manitoba?

Hon. Michel Côté (Minister of Regional Industrial Expansion): Mr. Speaker, I think I will simply put matters back into context, and also mention to the Hon. Member that, first, this is a corporate decision, a decision that was made because we were told the plan was very old and it was becoming hard for the company to modernize the system. We have always entertained an interest in the matter, and we have indeed asked to meet the corporation's president in order to explore the possibilities. If the company is interested in proceeding with a modernization plan, I can assure the Hon. Member that this Government is very much concerned about regional development and we will keep on pursuing that goal.

Mr. Blaikie: The fact is, Mr. Speaker, that the company had made a request to the federal Government for assistance in modernizing its plant. Instead the federal Government chose to give money to the new plant in Neepawa, which contributed to the situation before us today.
