

GRANTS TO IMPERIAL OIL, ALBERTA

Question No. 2,559—**Mr. Mazankowski:**

What is the location, and what are the facilities constructed by Imperial Oil Ltd., in Alberta, as referred to in Question 2,437, which qualified for two grants of \$5 million, under the Area Development Agency?

Mr. Russell C. Honey (Parliamentary Secretary to the Minister of Regional Economic Expansion): The two facilities are located near Redwater, Alberta and provide for the manufacture, by different processes, of phosphatic fertilizer and nitrogenous fertilizer.

As at Sept. 30, 1968 the total number of persons employed was as follows: Departments and departmental corporations, 234,394; Crown corporations, 144,871; Total, 379,265.

2. Total number employed in Quebec by departments and departmental corporations as at Sept. 30, 1968, 38,976; Total salary for the period Jan. 1 to Sept. 30, 1968, \$161,907,000.

3. Total number employed in Quebec by Crown corporations as at Sept. 30, 1968 was 35,132; Total salary for the period Jan. 1 to Sept. 30, 1968 was \$186,481,000.
