bumbly befeech Pour Majesty that it may be enacted: and be it enacted by the King's most Ercellent Wafesty. by and with the Advice and Consent of the Lords Spiritual and Tempolal, and Commons, in this present Parliament assembled, and by the Authority of the same, That it thall and may be lawful to and for the King's most Excellent Wajelly, by Warrant of Warrants under this Royal Sian Manual, to authorize and impower the Commissioners of Dis Wajelip's Treasury now of for the time being, or any Three or more of them, or the Lord high Trealuter for the time being, at any Cime or Times before the Fifth Day of January, One thousand seven hundred and arty, to cause or direct any Loans to be taken or received at his agaicay's Erchequer from any Person or Persons, Matives of Foleigners, Body of Bodies Politick of Copposate, of any Mumber of Exchequer Bills to be made out there, for any Sum or Sums of Money, not erceeding, in Loans and Erchequer Bills together, in the Whole, the faid Sum of One Million, in the same oz fer as is pre-feribed by the like Manner, Fozm, and Dider, and according to the Land Tax Act same of like Rules and Directions, as in and by an Act of this present Sesson of Parliament, intituled, An Act for granting an Aid to His Majesty by a Land Tax, to be raised in Great Britain for the Service of the Year One thousand seven hundred and fifty nine, are enasted and prescribed concerning the Loans or Exchequer Bills to be taken or made in pursuance of the said Aft.

and be it further enacted by the Authority aforesaid, That all and every the Clauses, Provisoes, Powers, Pris vileges, Advantages, Penalties, Fozseitures, and Disavilities, contained in the said last-mentioned Act relating to the Loans or Erchequer Bills authorized to be made by the same Ait (ercept such Clauses as do charge the same on the Cares granted by the same Ad, and except such Clauses as limit the Rate of Interest to be paid for the Folbearance of Adonep lent on the Arcditiof the laid Acti shall be applied and extended to the Loans and Erchequer. Bills to be made in pursuance of this Adi, as fully and effectually to all Intents and Purpoles, as if the lame Loans or Exchequer Bills had been originally authorized by the said last-mentioned Ad, or as if the said several Clauses or Provisoes had been particularly reveated and re-enaded in the Body of this Ad.

And be it further enacted by the Authority aforefaid. That all such Loans of Erchequer Bills, together with the Interest. Premium, Rate, and Charges, incident to or attending the same, shall be, and are hereby chatged and chargeable upon, and half be repaid of borne by of
