House upon Partridge Island, and to make provision for the future support thereof, and of other Light Houses at the entrance of the Harbour of Saint John."

Mr. Gilbert in the Chair of the Committee.

Mr. Speaker resumed the Chair.

The Chairman reported, that they had gone into consideration of the Bill referred to them, and made progress therein, and that he was directed to ask leave to sit again.

Ordered, That the report be accepted and leave granted.

Mr. Weldon gave notice, that he would, on Monday next, submit a Resolution, declaring it inexpedient any longer to continue the appointment of Province Agents in Great Britain.

Read a second time, the following Bills :--

A Bill to continue an Act, intituled, "An Act further to increase the Revenue of the Province, by imposing a duty upon all Rum and other Spirituous Liquors that shall be destilled within the same."

A Bill to continue an Act, intituled, "An Act to lay a Tax on Dogs in certain parts of the Parishes of Fredericton and Saint Andrews."

A Bill to regulate the Salmon Fishery in the County of Northumberland, and to repeal all the Laws now in force relative to the same, as far as they relate to the said County of Northumberland."

A Bill to repeal the Act, intituled, "An Act for the conviction and punishment of Criminals who shall refuse to plead when arraigned, and for the trial of those who shall peremptorily challenge more than twenty."

The House adjourned until to-morrow morning, at half past nine o'clock.
