

### WEST LAND REGULATIONS.

Any person who is the sole head of a family, or any mail over 18 years old, may homestead a quarter section of available Dominion land in Manitoba, Saskatchewan er Alberta. The appli-cant must appear in person at the Dominion Lands Agency or Sub-Agency for the district. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister of in-tending homesteader. Duties.—Six months' residence upon and culivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres solely owne and ccupied by him or by his fath e mother, son, daughter, brother Any person who is the sole head of a

other, son, daughter, brother

sister. In certain districts a homesteader a good standing may pre-empt a quarter-section alongside his homestead. Price \$3.00 per acre, Duties.—Must re side upon the homestead or pre-emp tion six months in each of six years from date of homestead entry (includ-ing the time required to earn home-stead patent and cultivate fifty acres extra.

extra. A homesteader who has exhausted his homestead right and cannot obtain a pie-emption may enter for a pur-chased homestead in certain districts, Price \$3.00 per acre. Duties.—Must re-side six months in each of uhree years, cultivate fifty acres and erect a house worth \$300.00.
