first and second years of the School course respectively, constitute the First and Second Intermediate Examinations respectively, which by the rules of the Law Society, each student and articled clerk is required to pass during his course ; and the School examination which includes the work of the third year of the School course, constitutes the examination for Call to the Bar, and admission as a Solicitor.

Honors, Scholarships, and Medals are awarded in connection with these examinations. Three Scholarships, one of $\$ 100$, one of $\$ 60$, and one of $\$ 40$, are offered for competition in connection with each of the first and second year's examinations, and one gold medal, one silver medal, and one bronze medal in connection with the third year's examination, as provided by rules 196 to 205 , both inclusive.

The following Students-at-Law and Articled Clerks are exempt from attendance at the School.
I. All Students-at-Law and Articled Clerks attending in a Barrister's chambers or serving under articles elsewhere than in Toronto, and who were admitted prior to Hilary Term, 1889.
2. All graduates who on the 25 th day of June, 1889, had entered upon the second year of their course as Students-at-Law or Articled Clerks.
3. All non-graduates who at that date had entered upon the fourth year of their course as Students-at-Law or Articled Clerks.

In regard to all other Students-at-Law and Articled Clerks, attendance at the School for one or more terms is compulsory as provided by the Rules numbers 155 to 166 inclusive.

Any Student-at-I.aw or Articled Clerk may attend any term in the School upon payment of the prescribed fees.

Students and clerks who are exempt, either in whole or in part, from attendance at The Law School, may elect to attend the School, and to pass the School examinations, in lieu of those under the existing Law Society Curriculum. Such election shall be in writing, and, after making it, the Student or Clerk will be bound to attend the lectures, and pass the School examination as if originally required by the rules to do so.

A Student or Clerk who is required to attend the School during one term only, will attend during that term which ends in the last year of his period of attendance in a Barrister's Chambers or Service under Articles, and will be
entitled to present himself for his final exam ination at the close of such term in May, although his period of attendance in Chan ${ }^{1}$ bers or Service under Articles may not have expired. In like manner those who are required to attend during two terms, or three terms, will attend during those terms which end in the last ${ }^{200}$ or the last three years respectively of their per iod of attendance, or Service, as the case ${ }^{\left(\mathrm{m}^{2}\right)}$ be.

Every Student-at-Law and Articled Clerk before being allowed to attend the School, mint $^{\text {5t }}$ present to the Principal a certificate of the $\mathrm{Sec}^{\circ}$ retary of the Law Society shewing that he ${ }^{h^{25}}$ been duly admitted upon the books of the Society, and that he has paid the prescribed ${ }^{\text {fee }}$ for the terrr.

The Course during each term embraces $1 \mathrm{le}^{\circ}$ tures, recitations, discussions, and other oral methods of instruction, and the holding of $\mathrm{mOO}^{\mathrm{Ot}}$ courts under the supervision of the Principal and Lecturers.

During his attendance in the School, the Student is recommended and encouraged to devote the time not occupied in attendanct upon lectures, recitations, discussions or $\mathrm{m}^{00 \mathrm{t}}$ courts, in the reading and study of the books and subjects prescribed for or dealt with ${ }_{\text {as }}{ }_{5}$ tar course upon which he is in attendance. As with as practicable, Students will be provided with room and the use of books for this purpose. and
