Of J. B. Ferris and others ; praying for an Act of Incorporation under the name of the Campbellford, Lake Ontario and Western Railway Company.

Of the Kettle River Valley Railway Company ; praying for the passing of an Act to extend the time for the completion of their lines of railway authorized by Parliament, and for other purposes.

Of the British Columbia Southern Railway Company; praying for the passing of an Act to extend the time for the construction and completion of the Eastern and Western sections of their railway and branches, authorized by Parliament.
