

(C) Strike out line 47 on page 2, and substitute the following therefor:

"vision for fees, other than fees related to the right to grow the regulated product, payable to the ap—"

(D) Strike out lines 7 and 8, on page 3, and substitute the following therefor:

"product or the marketing thereof and"

(E) Strike out lines 11 to 13 both inclusive, on page 3, and substitute the following therefor:

"levies or charges, if any, payable by the members of each such group;"

*Clause 3:*

(A) Strike out line 5, on page 4, and substitute the following therefor:

"bers, at least 50% of whom are primary producers, to be appointed by the Governor in"

(B) Strike out line 10, on page 4, and substitute the following therefor:

"be the vice-chairman thereof, one of whom shall be a primary producer."

(C) Add immediately after subclause (2) the following new subclause:

"(3) That at all times in making appointments, the Governor in Council shall try to keep the composition of the Council one-third of the members from the four Western Provinces, one-third from the two Central Provinces and the one-third from the Atlantic Provinces."

(D) Renumber subclauses (3) and (4) as subclauses (4) and (5) respectively.

*Clause 5:*

Strike out subclause (1), on page 4, and substitute the following new subclause therefor:

"(1) A member of the Council who is not employed in the public service of Canada shall be paid a salary to be fixed by the Governor in Council."

*Clause 6:*

Strike out paragraph (b) of subclause (2), on page 5.

*Clause 7:*

(A) Strike out line 1, on page 6, and substitute the following therefor:

"7. (1) In order to fulfill its duties the Council"

(B) Strike out lines 2 and 3, on page 6, and substitute the following therefor:

"(a) on receipt of a written request from one or more associations representing a significant number of persons engaged in the growing or production of the farm product or farm products in Canada or if directed to do so by the Minister shall, or on its own initiative may,"

(C) Add, immediately after paragraph (c) of subclause (1), the following new paragraphs:

"(d) shall review all orders and regulations that are proposed to be made by agencies and that are of a class of orders or regulations to which the Council, by order, provides that this paragraph is applicable and, where it is satisfied that such orders and regulations are necessary for the implementation of the marketing plan that the agency proposing to make the orders or regulations is authorized to implement, the Council shall approve the orders and regulations;

(e) shall review all orders and regulations that are made by agencies and that are not of a class of orders or regulations to which paragraph (d) is made applicable, and, where it is satisfied that such orders or regulations are necessary for the administration of the marketing plan that the agency that has made the orders or regulations is authorized to implement, the Council shall approve the orders or regulations and, where it is not so satisfied, the Council may, by order, set aside any such orders and regulations;

(f) shall make such enquiries and take such action within its powers as it deems appropriate in relation to any complaints received by it from any person who is directly affected by the operations of an agency and that relate to the operations of such agency;"

(D) Reletter the actual paragraphs (d) to (f) as paragraphs (h) to (j).

(E) Strike out line 40, on page 6, and substitute the following therefor:

"(g) may conduct studies of, and on its own initiative or on the"

(F) Strike out, lines 45 to 49, both inclusive, on page 6, and line 1, on page 7, and substitute the following therefor:

"(h) may, for the purpose"

(G) Add, immediately after paragraph (h), the following new paragraph:

"(i) may, when in its opinion it is necessary to do so for the purpose of determining the advisability of establishing an agency in respect of a farm product or of vesting an agency with power to implement a marketing plan, require persons engaged in the production of a farm product for, or the marketing of a farm product in, interprovincial or export trade to submit to the Council or the appropriate agency such information relating to the production or marketing of the farm product by them as it may reasonably require; and"

(H) Add, immediately after subclause (1), the following new subclause:

"(2) The Council, in reporting to the Minister under subsection (1), shall not recommend the establishment of an agency in respect of a farm product or farm products or the broadening of the authority of an existing agency by vesting it with powers in relation to a farm product or farm products unless it is satisfied that a majority of the producers of the farm
