STATEMENT ON DISPOSITION OF DEFERMENTS

Nicholson (Minister of Labour): On Thursday last, the hon, member for York South inquired as to what action had been taken with regard to requests for deferment under the Canadian Labour (Standards) Act, and I assured him I would look into the matter and give him the information at a later date.

Eight applications for deferment of wages have been rejected while none have, as yet, been granted. This of course, was under the previous minister. With respect to hours, one request for deferment has been granted. In this case both the employer and the union requested the deferment.
